- 4) A student can be dismissed at the discretion of the School Director for insufficient progress, non-payment of fees, or failure to comply with school rules and policies outlined in this catalog.

Golden Paws Academy's Cancellation Policy

Golden Paws Pet Styling Academy foresees no reason to cancel the program. However, if at any time the program is cancelled, all tuition monies will be refunded in full, or Golden Paws Academy will finish teaching the class to the completion date of each student enrolled.

Golden Paws Pet Styling Academy's Refund and Withdrawal Policies

- B) if the program of instruction is discontinued by the school and this prevents the student from completing the program; or
- C) if the student's enrollment was procured as a result of any misrepresentation in advertising, promotional materials of the school, or misrepresentations by the owner or representatives of the school.

Refund Policy for students called to Active Military Service:

A student of the school who withdraws from the school as a result of the student being called to active duty in a military service of the United States or the National Guard may elect one of the following options for each program the student is enrolled in:

- A) If tuition and fees are collected in advance of the withdrawal, a pro rata refund of any tuition, fees or other charges paid by the student for the program and a cancellation of any unpaid tuition, fees or other charges owed by the student for the portion of the program the student does not complete following withdrawal;
- B) A grade of incomplete with the designation "Withdrawn-Military" for the courses in the program, other than courses for which the student has previously received a grade on the student's transcript, and the right to re-enroll in the program, or a substantially equivalent program if that program is no longer available, not later than the first anniversary of the date the student is discharged from active military duty without payment of additional tuition, fees or other charges for the program other than any previously unpaid balance of the original tuition, fees and charges for books for the program; or
- C) The assignment of an appropriate final grade or credit for the courses in the program, but only if the instructor or instructors of the program determine that the student has:
 - a) Satisfactory completed at least 90 percent of the required coursework for the program; and
 - b) Demonstrated sufficient mastery of the program material to receive credit for completing the program.
